Cllr Buchanan informed the meeting that Planning has contacted Air Traffic Control regarding the shielding of the turbine lights and asking if they had suggestions on how to reduce the light pollution. Planning have been told that LED lights that automatically come on when a signal from an incoming plane could be a solution. They are awaiting a response from ATC.

The bus stop at 88 Neilston Road has still not been relocated but is on the works list to be completed.

There have been a number of complaints from residents regarding the reliability of the new Henderson hybrid buses.

John Black & Kenny Knox

As this point, David asked the above residents to take the floor regarding an issue they wished to raise with UCC.

They wanted to discuss a planning application for a house that had been lodged for a vacant lot in Braefoot Lane. This lot borders a number of properties including Mr Knox and Mr Black's houses. A number of plans/drawings and emails between the residents and ERC Planning Department were shown and explained. Their concern is that there appear to be a number of inconsistencies and irregularities in the planning process that they felt could affect the decision of the planning committee. The residents have taken this issue up with the local Councillors who have agreed to

look into it. Joyce informed them that they are able to request an appointment at Council HQ to discuss their concerns and that they can also initiate the formal complaints procedure with ERC. They were advised that although they cannot lobby the members of the Planning Committee, they can write to them before the site visit outlining their concerns.

Action

• Mr Knox is to provide a summary of the issues concerning the application with supporting evidence and pass to David. David will then compose a letter to ERC Planning expressing our concerns with the irregularities in the process.

David suggested it may be worth carrying out a survey ourselves.
